

Purpose of Grassroots Grants

To assist and support FNDD Precinct Chairs or Precinct Captains with the organization of their precincts. FNDD would provide Grassroots Grants (GG) of up to \$100 to cover expenses for precinct organizing activities. Members are limited to receive only one GG in an 18 month period. Thus FNDD members who receive a GG must wait 18 months from date of GG disbursement before they can apply for an additional GG.

Requirement for eligibility for GG

Current dues paying FNDD member
Precinct Chair or Precinct Captain

Eligible Activity for GG

Grants to be spent on activities related to precinct organizing. Example activities include:

- § Precinct Meeting at home or public location for precinct organizing purposes
- § Organization of precinct walk
- § Design cost and maintenance of website for Precinct Chair or Precinct Captain. Primary purpose of website should be used for organization and communication to local Precinct Democrats

Funding of GG comes out of FNDD general budget and assumes available budget, GG program will be temporary suspended when funds for GG program are depleted for the year.

Eligible Reimbursable costs

GG can cover:

- § Printing and postage of mailing to precinct Democrats
- § Rental costs for room to have a precinct organizing meeting
- § Refreshments and snacks etc for precinct organizing meeting

Process for Reimbursement

§ Prior to organizing activity, FNDD member must get pre approval for GG funding. Applicants should send their application to FNDD Grant Committee (FNDDGC) for review and consent. Give the FNDDGC committee as much time as possible prior to organizing activity to review and approve activity. Its is suggested to submit application to FNDDGG committee a minimum of 21 days prior to activity.

§ FNDDGC will communicate to applicant their decision on GG application with 10 days of receiving completed application.

§ Upon approval of FNDDGC and completion of activity, applicant must send a cover memo briefly to overview activity with copy of receipts to be reimbursed and copy of activity sign in sheet if applicable

Next Steps

- approve language of GG description

- design 1 page application
- link application to FNDD website
